READ BEFORE APPLYING

MWC supports the Drug-Free Workplace Act of 1998 that prohibits the unlawful manufacture, distribution, dispensation, possession, or use of illegal drugs or alcohol in the workplace. Any employee who violates this policy will be subject to appropriate disciplinary action, up to and including discharge. Employees (captains, deckhands, etc.) whose responsibilities include navigation or safe handling of the vessel are required to provide pre-employment drug testing and are subject to random drug testing during the season.
